6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

Precautions to be taken in handling and storage:

Keep away from heat, sparks and open flame. - No smoking. Keep container closed when not in use. Do not store above 120 degrees F. (49 degrees C).
